You are, therefore, advised to contact the University / Institution in which you have already registered/wish to do M.Phil. or Ph.D. for the award of Junior Research Fellowship.

The concerned institution should verify the original certificates of the candidate. Wherever PH or VH appears in the UGC - Ref. No., the relevant documents of Physical or Visual disability should be checked. It should also be verified whether the candidate fulfils the minimum eligibility conditions for Junior Research Fellowship (JRF), i.e., at least 55% marks in Master's Degree (or) equivalent examination from a university/institution recognised by UGC for General/OBC and 50% for SC/ST/PH/VH candidates within two years from the date of declaration of UGC-NET result.

The candidate should not be more than 28 years of age as on the first day of the month of the concerned UGC-NET, relaxable by five years for SC/ST/OBC/PH/VH/ Female candidates. Relaxation in age up to 3 years is provided to candidates who have done LLM and to research scholars for the period of research. Total relaxation on the above ground(s) cannot exceed five years.

The certificate for Lectureship eligibility is being issued separately.
